Take note of the following information and govern yourselves accordingly.

- ➤ Some surveys have been conducted concerning the 2020 Imperial Council/Court Session. No surveys have been authorized by the Imperial Potentate to be conducted concerning the 2020 Imperial Session; therefore, all surveys should cease immediately.
- ➤ No information is to be disseminated concerning the actions of the Imperial Council Divan relative to the business of the Imperial Council/Court unless it comes from the Headquarters Office under the signature of the Imperial Potentate.

- ➤ We encourage you to take the ICED training modules while you are not having meetings.
- ➤ We are in the age of electronic communication. All members should make sure all their contact information in the member suites portal is current in order to receive electronic information.
- ➤ When information is sent to those persons who are on the Headquarters e-mail lists, the information must immediately be sent to Nobles and Daughters for whom you have e-mail addresses. This information is also posted on both websites.
